THESE ARE SET ASIDE CONTRACTS FOR PEOPLE WITH SEVERE DISABILITIES THROUGH THE JAVITS-WAGNER-O'DAY ACT OF 1971. GSSI IS CURRENTLY ENGAGED IN CUSTODIAL, POSTAL SERVICES AND GROUNDS MAINTENANCE CONTRACTS THROUGH THIS PROGRAM. EMPLOYEES ARE PAID THROUGH A MANAGEMENT AND ADMINISTRATIVE SERVICES CONTRACT WITH GOODWILL INDUSTRIES INC. IN 2019, GSSI WAS RESPONSIBLE FOR OVER 3,000,000 SQUARE FEET OF BUILDINGS FOR VARIOUS JANITORIAL CONTRACTS AT OFFUTT AIRFORCE BASE, STRATCOM, ZORINSKY FEDERAL BUILDING AND DENNEY FEDERAL BUILDING IN LINCOLN. GSSI WAS ALSO RESPONSIBLE FOR GROUNDS MAINTENANCE AT THE VA HOSPITAL IN OMAHA, NE AND GRAND ISLAND, NE. GSSI ALSO
